## Article 2.

Both parties will make proposals for the implementation of these exchanges & work towards their realization in consultation contact with each other.

### Article 3.

This memorandum may be altered by mutual written consent of both parties by the request of either i.e. JCJ or PARIS Institute. Any alterations shall become effective at the time that both parties indicate their consent in writing.

### Article 4.

The present memorandum shall be effective for a period of three year form the date it is signed by both parties. Its period of validity may be extended by mutual consent in writing. The termination of its Memorandum shall not affect the implementation of the projects or programs undertaken/ established under it, prior to such termination.


### Article 5.


Financial terms for the specific projects shall be decided with mutual agreement between JCJ and PARIS Institute
